Dichromatic Vision

Normal vision is trichromatic; that is, there are three kinds of cone cells.

- Protanopia: missing L cones
- Deuteranopia: missing M cones
- Tritanopia: missing S cones. Fovea cone cell

Dichromatic color vision: one class of cone cells are missing.

Lines of Confusion

For a protanope (which lacks L cones), all the colors that have the same M and S cone responses but differ in L would be perceived as the same color.

All the colors on a line parallel to the L-axis are seen as the same color by a protanope.

- C1~C4 are seen as the same color

- Cone sensitivity peaks shift away from the normal peaks

	- Each anomalous individual has a slightly different shift

• Sensitivities of different cone types are more similar → weaker color discrimination

Human Tetrachromacy

- Some people have four cone types, but they do not exhibit stronger color discrimination.
- Why? No neural circuits that can make use of the fourth cone type?
- Another view: neural circuits are plastic and can be trained to make use of the fourth cone type.

• Bees have three photoreceptors, but their sensitivities are shifted toward lower wavelengths.

- So they can see UV lights but can't distinguish between red and black.
- Karl von Frisch, one of the first to experimentally show bees see color.

What If Only One Photoreceptor Type Exists?

Then you don't see color at all: you see only brightness differences

- Rod monochromacy (20 per million people):
	- No cones, only rods
	- Rods are very sensitive to lights are usually activated at night so people with rod monochromacy have to wear very dark sunglasses
	- There are no rods in fovea, so people with rod monochromacy have low visual acuity
	- Knut Nordby (1942 2005)
- Cone monochromacy:
	- Most common is blue cone monochromacy: only S cones exist (why?)
	- At mesopic (twilight) vision they might have weak dichromacy

Intuition Behind Rotation

Could Rotational Shifts Be the Missing Dimension?

Requirement 1: rotational shifts must have discriminative power • That is, originally confusing colors will become distinct through rotation

Requirement 2: rotational patterns must be easy to learn

- So that we can associate a pattern with a color name

• **opposite** side of the iso-chrome lines → colors shift in opposite directions

• **same** side of the iso-chrome lines → colors shift in different "speeds"

Confusing colors have unique color shift patterns — a third dimension that have **discriminative power**.

We tested the Maxwell–Cornsweet conjecture that differential spectral filtering of the two eyes can increase the dimensionality of a dichromat's color vision. Sex-linked dichromats wore filters that differentially passed long- and middle-wavelength regions of the spectrum to each eye. Monocularly, temporal modulation thresholds (1.5 Hz) for color mixtures from the Rayleigh region of the spectrum were accounted for by a single, univariant mechanism. Binocularly, univariance was rejected because, as in monocular viewing by trichromats, in no color direction could silent substitution of the color mixtures be obtained. Despite the filter-aided increase in dimension, estimated wavelength discrimination was quite poor in this spectral region, suggesting a limit to the effectiveness of this technique.

Jawless vertebrates

- Through many gene duplications, proto-vertebrates (ancestors to vertebrates) possessed 4 classes of genes, each coding a pigment class.
	- Originally there was 1, which was duplicated to be three (one for melanopsin expressed in ipRGCs, another expressed in RPE, and another called C-opsin).
	- C-opsin is duplicated to form pinopsin and a cone opsin, which is the LWS opsin.
	- The LWS opsin is duplicated multiple times, first to form SWS, and then SWS is duplicated to SWS1 and SWS2, and then SWS2 is duplicated to form RHL, so in the end porto-vertebrates have LWS, SWS1, SWS2, RHL. Of course these are ancestral genes, and their extant variants are different.
	- RHL means "rod like"; it was given the name because its duplicate later evolved to be expressed in rhodopsin.

- Then there were two rounds of Whole Genome Duplication (WGD)
	- Happened ~530–500 Mya toward the end of the Cambrian epoch.
	- The two rounds of WGD quadrupled the number of genes, but each duplication was followed by extensive loss of genes (so not all 4 copies of a gene remained).
	- WGD led to an explosion of new species (more genes available to be mutated, etc.).
- Vertebrates appeared after 1R. After 1R, ancestral vertebrates possessed five opsin genes
	- SWS1, SWS2, RH1, RH2, and 1 LWS (not all 4 copies of each gene were retained; 2 copies of RHL were retained: RH1 and RH2)
	- 1R also duplicated other non-opsin genes important for phototransduction (e.g., G proteins, PDEs, cGMPs, etc.)

- 1R is important for the rod-cone duplex vision in today's vertebrates:
	- RH1 evolved to become ancestral rhodopsin (pigment for rods).
	- And other non-opsin, phototransduction genes duplicated from 1R also evolved to express different isoforms in cone and rod photoreceptors today.
- Then jawless and jawed vertebrates split.
	- Both jawless and jawed vertebrates possess scotopic and photopic vision (see above). • In fact proto-vertebrates had scotopic vision too, but that was mediated by pinopsins.

- 2R happened to only jawed vertebrates.

	- lampreys have rods that look like cones but physiologically behave like rods [Morshedian and [Fain 2015\]](https://www.cell.com/current-biology/pdf/S0960-9822(14)01634-0.pdf). Whether you call that a rod or a cone is largely a matter of opinion.

• 2R introduces a few new genes that allow jawed vertebrates to possess true, modern rod

• For instance, in jawless vertebrates rods and cones look very similar, but 2R changed the morphology of rods in jawed vertebrates so that they look differently than cones.

• But morphology apparently isn't important for scotopic vision: northern hemisphere

- Some proto-vertebrate already had four classes of genes (through local gene duplications) that code four different pigments/opsins
- A descent of this creature went through two rounds of WGD
	- Whole Genome Duplication; ~530–500 Mya (Cambrian epoch)
	- Each followed by extensive loss of genes (so not all 4 copies of a gene remain)
	- Now five classes of opsins (SWS1, SWS2, RH1, RH2, and LWS)

• For life at night & in deep ocean; rod pathway piggybacks on existing cone pathway

• Early mammals (~age of dinosaurs) are nocturnal so they lost two genes

- RH1 gene evolved (~500-430 Mya?) to express rod pigment
	-
- - Only LWS and SWS1 genes retained and expressed in cone pigments
- Trichromacy emerged in Catarrhini (common ancestors of old world monkeys, apes, and humans) through gene duplication

* Only the first two genes are sufficiently expressed to affect pigments [Simunovic 2009]

Genetic Basis of Color Vision Deficiency

- L and M genes are tandemly arrayed and are subject to crossovers during recombination, which might lead to deletion of a whole gene or hybrid genes in a X chromosome.
	- Inheriting such an X chromosome causes CVD.

The spectral sensitivities of the hybrid photopigments vary between those of the M- and L-cones depending

Why is CVD More Prevalent in Males?

• Genes for L and M cone pigments lie together on the X chromosome and are thus

- Most CVDs are due to L/M genes cross-overs on X chromosomes
	- subject to unequal recombination/crossovers
	- Females have two X chromosomes

Why are S-Cone CVDs Rate?

• Gene for S cone pigment is in a nonsex chromosome (chromosome 7)

- - They are not subject to L/M gene cross-overs
	- Gene mutations causing changes in S-cone pigment are much more rare

Things to Take Away

- Dichromats miss one class of cone photoreceptors (functionally)
- Each dichromatic vision has a set of parallel confusion lines
	- Colors on the confusion lines are perceptually the same for a dichromat
	- Confusion lines converge in the xy-chromaticity plot
	- Color matching experiments on unilateral dichromates allow us to estimate what colors are correctly perceived by dichromats
- Computational trichromacy reconstruction
- Color vision deficiencies in humans are due to erroneous LM gene duplication that happened at the basis of old-world primates
